Late applications will be considered as discontinuation of studies and the paid retention fee will be forfeited, non-refundable or non-transferrable.

## 申請「休學」須知

- 一、申請人必須為本校已註冊學生及已繳清按規定應繳之費用。
- 二、休學申請須於正常修業期限內向所屬學院辦公室提出申請，並須附上有關證明文件(例如:有效之醫生證明信)或解釋信件。
- 三、學院收到填妥之申請表格及/或有關文件後，方可處理台端之申請。
- 四、費用：

I	學期/學年開始 <u>前</u> 或學期/學年開始後 <u>10 個工作日內</u> 提出申請	將在已繳之保證金內扣除休學留位費(註)。若已繳交該學期/學年學費者，學費會予以保留，在學生復學後使用。
II	學期/學年開始 <u>10 個工作日後</u> 提出申請	將在已繳之保證金內扣除休學留位費(註)及已繳之該學期學費將不予保留、退還或轉讓。

註: 休學申請一旦獲批，將在已繳之保證金內扣除休學留位費澳門幣 3000 元(適用於本澳生)/港幣 3000 元(適用於外地生)。

- 五、若學生於開課前提出休學申請及其申請成功獲批，該生已登記於開學後修讀的科目將被註銷。
- 六、休學期間，學生不得參與大學的任何課堂及其他教學活動。
- 七、學生如未能在指定學期／學年復課，將以停學處理，已繳學費將不予退還。
- 八、收集個人資料聲明：閣下在本表格內所提供的個人資料僅作本校職員處理此申請之用。

### Notes for Application for Deferral of Studies

1. Only registered student who has paid the fees required is eligible for the application.
2. Applicants should submit the completed application forms to the respective faculty together with all necessary supporting documents (such as a valid medical certificate) or explanatory letter during their normal study period.
3. Applications will be processed upon receipt of the completed application form, and /or supporting documents.
4. Fee:

I	Applications received <u>before</u> the commencement of a semester or an academic year or <u>within 10 working days</u> of the commencement of a semester or an academic year.	The retention fee for deferral of studies is deducted from the caution fee (note). If the tuition fee paid for semester/academic year will be retained to offset tuition fee payable upon resumption of study.
II	Applications received <u>after 10 working days</u> of the commencement of a semester or an academic year.	The retention fee for deferral of studies is deducted from the caution fee (note). The tuition fee paid for semester/academic year is forfeited, non-refundable or non-transferable.

Note: Once the application is approved, the retention fee for deferral of studies is deducted from the caution fee of MOP3000 (for Local Students) / HKD3000 (for Non-local Students).

5. If the application for deferral of studies is approved before the commencement date, their registered courses for upcoming semester will be canceled.
6. The student cannot participate in classes and other academic activities at the University during deferral period.
7. The studies will be terminated by the University and no tuition fee will be refunded if the student fails to resume study in the designated semester/academic year.
8. Statement of personal Data Collection: The personal data provided in this form will be used by the University for the purpose of processing this application only.
