1. All information provided in the certificates and documents (included but not limited to ID card, entry permit, passport, household register in China (Hukou), education/degree certificate, transcript and medical examination report and so on) submitted to the University is true and valid.
2. I have no infectious diseases, psychotic disorder or serious diseases which will prevent attending the University of the rule under Macau Health Bureau during registration. I understand if suffer from the above diseases will not be able to register, student can retain admission qualifications for one year.
3. I understand that all information submitted and provided to the University must be true and accurate. If any information I submitted and provided does not fulfill the University's admission requirements, or is found to be false or inaccurate, the University will withdraw any offer of admission, whether accepted or not; and will be required to withdraw from the City University of Macau. If there is a suspected offence of forgery/altering documents/using false instrument, the University will pass it to the police for further investigation.
4. In compliance with Law the Personal Data Protection Act, I agree that my personal data will be transferred outside Macao when necessary.
5. I agree the University to collect, use and verify my information (include but not limited to identity document, graduation document from previous education, record document of entry and exit Macau and contact etc.) from entities concerned when necessary for academic purposes. I also authorize and agree other entities to release all my educational information to the University throughout the studies.
6. I fully comprehend and accept that once I am registered as a student, the data provided will form part of my enrolment document and will be used for all the purposes that comply with the regulations of the University or law.
7. I clearly understand the “Legal System of Entry-Exit Control, Stay and Residence Authorization” of Government of Macao S.A.R. I fully understand the Authorization to stay limit in Macao. If a non-resident ID holder violates the “Special Authorization to Stay” related regulations for foreign students, he/she will be unable to finish his/her studies due to the cancellation of right of stay.
8. The following statements are only applicable to Mainland Chinese Students:
 - (1) I am aware of CSCSE and DSES regulations and I am aware that failure to comply with CSCSE regulations, for instance, not receiving the “Admission Confirmation Letter” issued by DSES, not being granted the “Type D – Stay” of student status, or not meeting the minimum number of days of stay in the Macao SAR will result in my graduation certificate issued by City University of Macau no longer being recognized by CSCSE for the purpose of obtaining Foreign Education and Degree Recognition Certificate.
 - (2) I acknowledge that, according to the regulations of CSCSE and DSES, if students have changed in student identity status, and thus resulted in not fulfilling the CSCSE requirements for the education recognition to the Mainland residents, the degree obtained in the University will not be recognized by Ministry of Education of the People's Republic of China for the status of Mainland Chinese student
 - (3) I am aware that students who have not received “Admission Confirmation Letter” or are not granted the “Type D – Stay” during admission will not have the assistance by the University to apply for the “Special Authorization to Stay”, and will not be allowed to apply for any enrolment certificate and testimonial for extension purpose related to permission of stay for students.
 - (4) I clearly understand that the University will not collect my personnel file. Mainland students are advised to keep their personnel file at the Talent Exchange Service Center at their Household Registration.

I guarantee and am willing to comply with the above terms and conditions. All legal liabilities and consequences will be taken by the student if the studies is suspended or terminated; degree is deprived or not recognized by CSCSE and so on due to the above violations. Tuition and related fees paid are non-refundable and non-transferable.

I hereby understand that if I make false, inaccurate or untrue statements, or make any cheat, I shall bear any criminal liability.

Personal Information Collection Statement of City University of Macau

1. The personal data provided by the students to City University of Macau (hereinafter referred to as “the University”) through the “Registration System” and on the “New Student Data Sheet” in the University official website, during application for admission, (if admitted as students), programme registration and throughout the studies will be used by the University for the following purposes as permitted by the law: :
 - Verifying new students’ eligibility, selection for admission and other matters related to admission;
 - Verifying the students’ examination results, academic records and other related information;
 - For the purposes of education and teaching, scientific research, university administration, student management;
 - Liaising and communication for academic and administrative purposes;
 - Other activities that comply with the regulations of the University or law.
2. In accordance with Law (the Personal Data Protection Act), students’ personal data will be treated with strict confidentiality and will be used and managed by the University and its subsidiaries. The personal data may also be transferred to entities that are in accordance with legal provision or with prior consent of students, for the purposes of University administration.
3. In compliance with the Personal Data Protection Act, the University will transfer students’ data outside Macao when necessary.
4. In accordance with the Personal Data Protection Act, students who have filled in the personal data, have the rights of data access and revision according to the procedures as stipulated by the University whenever necessary. If student need to amend the name, the No. of ID card or any other information, please log in the TronClass system apply.
5. If there is any discrepancy between the Chinese and English versions of this declaration, the Chinese version shall prevail.
